Our Bottom-up fundamental research leverages proprietary screening and modelling tools to identify opportunities at the company level.



CAPITAL MARKETS: INVESTMENT PROCESS

The department uses a three-stage investment process in identifying opportunities. First, we conduct an in-depth macro research, which defines our big picture outlook, and then assess the opportunity set across the various asset classes and sectors. Lastly, we use proprietary screening and modelling tools, to identify opportunities at the company level. The process is valuation driven, with a bias to value over growth at a reasonable price. We constantly monitor risk to check potential variances in the portfolio's investment returns and where appropriate, adjust the allocation made in accordance with our outlook for the market.

CEO – Rasameel




Robert Aspin, CFA Consultant – Capital Market




Hamad AlSheikh Musaed
